## AMENDMENT

**Sub:-** Revised Major Works Schedule of Rates with effective from 01.04.2013 – Reg.  
**Ref:-** Order No. Dt.KPTCL/B19/7625/86-87 dated.01.04.2013- Approval of MWSR-2013.

The Major Works Schedule of Rates has been revised vide Order cited under reference with effective from 01.04.2013. During the 132<sup>nd</sup> Central Purchase Committee meeting of the T&P, the tender for design, manufacture, inspection, testing at works and supply of control and relay panels, annunciation equipment, synchronizing trolley and other miscellaneous equipments for 220kV Station of KPTCL were discussed and it was noted that the quoted rates of these items were comparatively less than that of the rates provided in the MWSR. The rates of these items in the revised MWSR were based on the average of packaged awarded rates for 220KV Sub-stations as these items are not directly procured by KPTCL during 2011-13. To have the rates of these items on par with the market rates, it was decided in the CPC meeting to adopt the quoted rates for the above items and to issue amendment to the MWSR in this regard.

It is also noted that the numerical distance relays for 220kV and 66kV class works on the same principles with almost same features. The number of input and output contacts for 220KV relays are more when compared to 66kV and 110kV class. Considering some of the additional features and additional input and output contacts, the rates of 220KV relays should be more than the rates of 110kV & 66 kV relays. However, the major features being similar, the agencies are quoting same price for both 220kV & 66kV or 110kV relays. Hence, it was decided that in the MWSR, the rates for 220kV and 66kV Numerical distance Relays can be adopted on par with the recently quoted rates of Rs.1,98,461/-

In view of the above, the rates for the above items in the MWSR is hereby amended and shall be read as follows.
