**Sub:-** Revised Typical Tender Notification Documents for arranging shift duties to 220kV, 110kV and 66kV Stations of KPTCL.- Reg.

**Ref:-** Letter No. KPTCL/IRO/B14/6014/2002-03 Dt.20.07.2015 - regarding approval of Typical Tender Notification Documents for outsourcing shift duties of KPTCL Sub-stations on contract basis to Agencies through tender.

Earlier vide letter cited under reference, the following Revised Typical Tender Notification Documents for arranging Shift duties to 220kV, 110kV and 66kV Stations of KPTCL are issued and requested to take suitable action in outsourcing the shift duties of KPTCL stations through tender.

1. Tender document for arranging shift duties to 66KV / 110KV Stations.
2. Tender document for arranging shift duties to 220KV Stations having 11KV reference
3. Tender document for arranging shift duties to 220KV Stations having no11KV reference.
4. Providing only shift helpers for arranging shift duties to 66KV / 110KV Stations.

Further, due to errors noticed in arrival of the minimum bid amount of the these tender documents, the above tender documents are corrected and enclosed with a request to outsource the Shift duties of KPTCL stations accordingly wherever needed, to the eligible private agencies, duly calling tender and finalizing the same with due diligence to KPTCL norms. In future, calling tenders for arranging Shift duties to KPTCL's Stations will be as per these Revised Typical Tender Notification Documents only. Inviting tenders for part of these tender Documents i.e., altering the staff pattern, etc., shall not be done failing which disciplinary action shall be initiated. The minimum bid amount arrived for each of the above tender documents is also enclosed herewith for your kind information.

During the contractual period of such newly awarded station shift duties,

- (a) as and when the applicable statutory charges payable by KPTCL are revised, necessary arrangements shall be made to pay such increase from its effective date.
- (b) Whenever GoK revises the minimum base wage and is found higher than that of the corresponding one indicated in the tender document, necessary arrangements shall be made to pay such increase effective from the date notified by KPTCL in this regard.

ESI charges are included in the minimum bid amount of each of the above tender documents. However, for the places(Station location) which are not covered under ESI facility, suitable arrangements shall be made in compitable with ESI facility duly following norms.

Any clarifications required regarding the labour related issues, statutory charges, minimum wages to be paid from time to time, legal issues, remuneration to the contractor etc., may be obtained from Deputy General Manager(Personnel) / Manager(Industrial Relations), KPTCL, Kaveri Bhavan, Bangalore.

The existing contract agreements with the Agencies in respect of Shift duties of KPTCL Stations shall be continued until their expiry / alternate arrangements are made through tender and awarded.
