Preamble: Order dated 03.03.2016 was issued authorising CEE Tr zones for renewal of currency of lapsed DPRs of their zones provided there is no change in the scope/scheme and no monetary change in the original DPRs. CEEs TR zones are requesting Corporate office for Renewal of currency of lapsed DPRs as there was revision of Major Works SR.

In order to speed up the process of Tenders where Renewal of Currency is required the order issued on 03.03.2016 has to be modified where corporate approval is required only when there is change in scope/scheme. Hence the revised order.

The Chief Engineers, Electricity, Transmission Zone, KPTCL are hereby authorized to renew the currency of the lapsed DPRs of their Zones provided there is no change in the scope/scheme in the original approved DPRs. However, for the DPRs where there is a requirement of change in the scope of works/scheme due to dynamics of the Transmission system (regardless of whether the currency has lapsed or otherwise) then such DPRs with changes in scope/scheme shall be referred to O/O Chief Engineer(Ele.) (P&C) to place it before TCC Meeting.

Also currency of DPRs can also be renewed by Zonal CEEs where there is no change in the scope/scheme and the value of the DPRs has changed only due to change in Schedule of Rates. Chief Engineers, Electricity shall record the reason for currency renewal and shall send copy of the same to Corporate office.
