**Sub: Renewal of currency for the Detailed Project Reports -reg.**

Ref: Note approved by M.D, KPTCL on 05.12.2015.

**Preamble:** The Corporate Office is being approached with requests seeking renewal of currency for the DPRs for which Administrative sanction has been accorded by the Corporation whenever the currency assigned to such DPRs gets lapsed. Further, any outlay that may be incurred thereafter against a Project whose currency has lapsed is to be treated as without sanction. As such, renewal of currency for a DPR is a must and shall be accorded by all the competent authority who is vested with the powers to accord Administrative sanctions.

Nevertheless, Administrative sanctions are also being accorded by the Corporate Office for DPRs. As such, and in order to simplify the process of according renewal of currency and to save time spent on renewing the currency for lapsed DPRs at the Corporate Office level, it is decided to authorize the Chief Engineers, Transmission Zone to renew the currency of such lapsed DPRs of their Zones. Hence the Order;

The Chief Engineers, Electricity, Transmission Zone, KPTCL are hereby authorized for renew of the currency of the lapsed DPRs of their Zones provided there is no change in the scope/scheme and no monetary change in the original approved DPRs. However, for the DPRs where there is a requirement of change in the scope of works/scheme due to dynamics of the Transmission system (regardless of whether the currency has lapsed or otherwise) then such DPRs shall be referred to Corporate Office seeking renewal of currency together with changes in scope/scheme.

The above order shall be followed scrupulously.
