In order to finalize the budget required for repair and maintenance works to KPTCL buildings all over the state for the FY 2013-2014, you are requested to furnish the following details in the enclosed format on or before 31/03/2013. The budget proposal shall be prepared duly following the instructions contained in Corporate circular dated 13/10/2008.

- 1. Budget requirement for R&M works proposed to be taken up in the FY 2013-2014 under Account Head 74.20/74.30/76.128/76.190.(as per annexure -A)
- 2. Budget requirement for R&M works taken up during the FY 2012-2013 which are likely to spill over to FY 2013-14.( as per annexure B)
  - a) Works completed and bills not submitted on or before 31/03/2013.
  - b) Works on going and bills due in FY 2013-14.
- 3. The consolidated and updated list of buildings as on 31/03/2013 and details of repair works carried out in FY 2012-13 (as per annexure -C)
- 4. Details of buildings which are proposed to be taken up for repairs during FY 2013-14 (as per annexure –D).

The details accounting unit wise, shall be obtained in the enclosed format and a consolidated statement for the zone shall be furnished before 31/03/2013 positively.

All estimates pertaining to R&M works proposed to be taken up under periodical repairs/ special repairs category for the financial year 2013-14 for which Corporate Office approval is required shall be sent to Corporate office on or before 30/04/2013.

Non receipt of said details within the time schedule mentioned above will be viewed seriously and will be presumed that there is no budget requirement under the above Account Heads in their zones.

Further, necessary action shall be taken to complete all R&M works to buildings and other civil works taken up during the current financial year and corresponding bills shall be passed before 31/03/2013. However if payment could not be arranged before 31/03/2013, necessary outstanding liability (OSL) shall be created in the final accounts.
