AMENDMENT

Sub: Amendment to the Corporate Order dated 17.08.2012 issued regarding "Sparing of land for construction of EHT line Terminal Bays with associated equipments in KPTCL Sub-station/Receiving stations for terminating power supply lines and evacuation lines of Independent Power Producers(IPP) and other connectivity issues"-reg.

Ref: 1) Corporate Order No. KPTCL/B28(a)/32543/2012-13 dated:17.08.2012
2) Note no. KPTCL/B36/41633/2016-17 dated: 22.03.2017 from FA(RA) approved by the Director(Finance), KPTCL.

Corporate Order cited under reference(1), was issued for constitution of a Committee to examine the feasibility of developing necessary infrastructure either for supply of power or for evacuation based on the requests of Generators or HT/EHT consumers subject to certain parameters. In addition to the Committee approving the said facilitation for building necessary infrastructure on KPTCL's premises at the cost of the applicant, the concerned applicant shall also pay certain additional fees.

As per the above Corporate order, KPTCL was collecting one time non-refundable charges and O&M expenses in respect of termination of evacuation lines constructed by the IPPs and generating stations to the KPTCL sub-station/receiving station and O&M expenses for termination of HT/EHT lines constructed by HT/EHT applicants to the KPTCL sub-station/receiving station for arranging power supply.

Now, KERC has passed the order on 26.02.2015 against O.P No. 13/2014 in which KERC has dismissed the collection of O&M charges from HT/EHT consumers and ordered to refund the amount so collected from HT/EHT consumers and also stated that KPTCL is entitled to collect O&M charges from IPPs, if the Petitioner maintains the dedicated transmission line.

Further, KERC in the Tariff Order 2016, determined the O&M charges to be collected for maintenance of Transmission lines and Bays by KPTCL for the FY17, FY18 & FY19 in addition to the other charges.

Hence, the following Amendment is issued with immediate effect:
